

## **ENROLLMENT**

Ogeechee Technical College enrolled **2,946 students** in credit courses during Academic Year 2020. This was the full-time equivalent (FTE) of 1,647 students (based on the sum of total credit hours for all students).

The College's **Student Retention Rate is 76.4**% of first-time, regular admitted students enrolled in Fall, who graduated or were still enrolled in a Georgia college or university as of the end of the next year (based on AY 2020 credit enrollment).




